



SIEGFRIED (SIGI) ENGL (1911 - 1982)

A stylish competitor and inspirational ski instructor, Siegfried (Sigi) Engl carved an indelible swath of accomplishments on the slopes of Europe and the Intermountain West.

A native of Kitzbuhel, Austria, Sigi was a ski instructor by age 15, won the Italian downhill and slalom championships in 1931, the Hahnenkamm combined and the famous Marmolata downhill in 1935. He won the Austrian slalom and downhill championships twice and was a member of the Austrian FIS World Championship Team for two years. In 1937 Sigi became an instructor at Badger Pass in Yosemite National Park, California, and two years later joined the ski school at Sun Valley, Idaho, where he won the prestigious Harriman Cup in 1941.

During World War II he was a member of the storied 10th Mountain Division serving in Italy. In 1952 Sigi became director of the Sun Valley Ski School where his innovative instructional methods vaulted the school into international prominence. He was inducted into the National Ski Hall of Fame in 1971 and in 1974 the president of Austria awarded him Austria's Golden Medal of Honor for his distinguished service. "Sigi's Bowl" on Sun Valley's Bald Mountain is a lasting tribute to the contributions he made to his beloved sport of skiing.

Bass, Engen, Engl, **Korologos Enter** Intermountain Ski Hall of Fame

UTAH OLYMPIC PARK, UT-Four men who made significant contributions to winter sports in the region in very far-reaching and diverse ways were inducted into the Intermountain Ski Hall of Fame on Thursday, September 24, 2009 (see accompanying biographies).

Induction ceremonies were held at the Joe Quinney Winter Sports Center at the Utah Olympic Park and attracted a capacity 180 well-wishers. The Intermountain Ski Hall of Fame was established in 2002 and the Class of 2009 increases the number of inductees to 42.

RICHARD D. (DICK) BASS (1929-)

Passionate dreamer, extroverted optimist, adventurous mountaineer and energized entrepreneur. Richard D. (Dick) Bass personifies each trait with nonstop verbosity and hyper-enthusiasm. A man of blanket curiosity and persevering determination, Dick's accomplishments

are mountainous, literally and figuratively. They range from being the first to reach the summit of the highest mountain on each of the world's continents to nurturing



Utah's Snowbird Ski and Summer Resort into a world-class, year-round destination. He was born in Tulsa, Oklahoma, but since the age of three has made Dallas, Texas, his home.

As a graduate of Yale in 1950, Dick's multi-faceted credentials include successful forays into geology, petroleum engineering, ranching and recreation. In 1962 he was one of the original investors in Vail Ski Resort and in 1986 co-authored the book, Seven Summits, about his climbing adventures. He was honored by the National Ski Areas Association (NSAA) in 2006 with their Lifetime Achievement Award. In June 2007, he received the Sheldon Coleman Great Outdoors Award from American Recreation Coalition (ARC) in Washington D.C., recognizing his significant contributions to skiing and recreation. His undaunted faith and innermost strengths are founded in his mantra that, "If it's meant to be, it's up to me." Utah's Snowbird Resort, which he opened in 1971, stands as a living testimonial to his words.

Each honoree received a plague bearing his likeness and biographical overview of accomplishments and achievements that merit Hall of Fame status. A similar plague was enshrined in the Will and Jean Pickett Intermountain Ski Hall of Fame, located in the main foyer of the

ALAN K. ENGEN (1940—)

An inherent love of skiing defines Alan K. Engen. A native of Salt Lake City, he started skiing at age two and was a skiing competitor by age nine. Alan was a five-time Intermountain junior ski champion and a five-time senior champion involving both Nordic and Alpine events. He was an All American skier for the University of Utah, member of the



U.S. military ski team which participated at the highest level of international skiing competition in Europe and was a perennial winner in U.S. Masters Series

ski events. He was named a Utah Ski Legend (1988), inducted into the Utah Sports Hall of Fame (1991), added to the honored roles of the U.S. National Ski Hall of Fame (2004) and inducted into the University of Utah Crimson Club Hall of Fame (2006). He meshed his quiet, persuasive manner with his passion for preserving the history of skiing in the West to record his most notable accomplishment—spearheading the building of the Joe Quinney Winter Sports Center/Alf Engen Ski Museum. He also authored two books on skiing, served as chairman and president of the Alta Historical Society, and was a charter member of the University of Utah J. Willard Marriott Library Ski Archives Advisory Board. He has been involved at Alta for over 50 years as a ski instructor, ski school director, and later Director of Skiing and was a torchbearer for both the 1996 and 2002 Olympic Summer and Winter Games. Alan Engen made skiing history by helping to perpetuate it.

MIKE C. KOROLOGOS (1937—)

Mike C. Korologos used the written word to leave his imprint on the annals of skiing. For



more than 50 years his writing and photographs enlightened readers of periodicals worldwide about winter sports in the Intermountain West.

His way with words was instrumental in Salt Lake City's successful quest to host the 2002 Olympic Winter Games. Mike served as communications director for the organizing committee of those games.

A native of Salt Lake City and a graduate of the University of Utah, Mike started his writing career at The Salt Lake Tribune where he was ski editor for 10 years. He received the State of Utah Tourism Achievement Award in 1984 and was named Ski Journalist of the Year in 1992 by Ski Utah. In 2003 he was awarded the Lifetime Achievement Award by the International Ski History Association.

A willing volunteer for numerous worthy causes, Mike was a charter member of the Alf Engen Ski Museum Foundation Board of Directors and a long-serving member of University of Utah J. Willard Marriott Library Ski Archives Advisory Board. If it pertained to skiing, Mike had a word for it.

The Hall of Fame selections are made annually by knowledgeable winter sports historians from Utah, Idaho and Wyoming. Selection is based on outstanding achievements in the areas of skiing competition, skiing innovations, ski sport development and significant contributions to the overall promotion of winter sports the Intermountain West. Nominees for the honor originate with the public and with volunteer members of the Ski Archives advisory board. Housed in the J. Willard Marriott Library at the University of Utah in Salt Lake City, the Ski Archives was founded in 1989 to locate, preserve, catalog and make available to the public the history of skiing in the region.

In Memoriam



BILL LEVITT— 1917-2009

In the Who's Who of Alta over the past half century, the name William "Bill"

Levitt stands among the first rank. Although not a native to Utah, as he once said, "I am one of Utah's most loyal patriots." Bill sadly passed away at his beloved Alta Lodge on December 29, 2009 while enjoying the company of his many guests.

Levitt, born February 18, 1917, started his skiing interest in the early 1930s. However, he did not take up the sport in earnest until the mid 1950s. It was then that he and his wife decided to go west and try skiing over the Thanksgiving holiday at Aspen, Colorado. However, because of marginal early season snow conditions at Aspen that year and based on a recommendation, they changed their plans and went to Alta instead. According to Levitt, that trip resulted in "a long-lasting love affair with that location high in the towering Wasatch Mountains." Levitt continued, "I had to make a choice, buy United Airlines so I could afford to continue coming to Alta on a frequent basis or purchase the Alta Lodge. I decided to do the latter and bought the lodge in 1959 from J. Laughlin."

Bill Levitt was first elected as president of the incorporated Town of Alta in 1971, and so remained until 1975 when the Utah Legislature changed the designation from President to Mayor. Levitt was unanimously re-elected, thus becoming Alta's first "elected" mayor. The only other person up until that time who carried that title was the late George Watson who self-appointed himself as Mayor of Alta in the late 1930s.

Levitt's reign as Alta's Mayor lasted

34 years. This stands as perhaps the longest continuous span of service provided by any mayor in Utah's history. Throughout his years as Alta's mayor, Levitt chose to limit his annual mayoral salary to \$1.00.

Tom Pollard, Alta's current elected mayor and Bill's replacement gave this comment: "Bill Levitt's passion for the job and his dedication to the community is something I hope to match...but it will be a daunting task to adequately fill his shoes." To this, all who knew Bill would agree. His passing leaves a hole in the Alta community that will remain for many years to come.



JERRY NUNN —1922-2009

America's first accredited woman forest ranger, Jerry Nunn, passed away on August 20, 2009, in Flagstaff, Arizona.

Jerry is especially remembered for participating in the 1957 Intermountain Forest Service Snow Ranger certification course held at Alta. When she initially pre-registered, no one knew, considering the way she spelled her first name, that she was a female... applying at that time for a spot in an entirely male dominated program. After lengthy discussion and considerable reservation, she was reluctantly allowed to participate and take the extensive exams which she passed with top honors. She

later went on to partner with the late Montgomery M. Atwater, legendary U.S. avalanche control expert, in development and marketing of the Avalauncher, a gas-powered gun used for avalanche control.

Jerry was considered a long time friend and supporter of both the Utah Ski Archives and the Alf Engen Ski Museum Foundation. She was inducted into the U.S. National Ski Hall of Fame in 2003.

ALBERT F. 'SUNNY' KORFANTA— 1915-2009

There was a very good reason Albert F. Korfanta was known as "Sunny". The moniker con-

veyed his personality, his demeanor and irrepressible smile.

Those attributes were his trademark during a remarkable lifetime of being a Pinedale, WY businessman, a willing volunteer, a caring ski coach and a ski area pionee


He and his wife, Fanny, partnered with the U.S. Forest Service to plan Surveyor Park Ski Area (later named White Pine Ski Area) and when it opened in January, 1940 they served as volunteer managers for decades afterward.

Korfanta coached and ferried young skiers from the Pinedale area to ski competitions in Utah, Idaho and Wyoming for several years and served as an officer of the Intermountain Division of the U.S. Ski Assn. In recognition of his numerous contributions to the enhancement of winter sports in the region, he was recognized at the 2007 Ski Affair as a Historymaker and was inducted into the Intermountain Ski Hall of Fame in 2008.

Sunny Korfanta died December 21, 2009, at age 94.



Celebrates Birthday At Snowbasin—On Skis



OGDEN, Utah (Jan. 15, 2010)—It was a festive day at Snowbasin today with Dew Tour action and local Ogden resident, Dr. Vernal Johnson, celebrating his 100th birthday. According to Dr. Johnson, he as been skiing at Snowbasin for 88 years.

He sat by the fire in Earl's Lodge, talking about his early experiences as Snowbasin. "We would drive up an old dirt road to get here," said Dr. Johnson. "We took and old chassis, tied a rope around an old tree on School Hill, put it in reverse, and made a rope tow to pull us up the hill," he said. When asked what he thought of the resort today, he smiled and said that it had changed a bit, but that it was wonderful. Mr. Earl Holding, owner of Snowbasin, extended a congratulatory handshake to Dr. Johnson. In contrast to the make-shift tow rope, Snowbasin now has one of the most advanced lift systems in the west.

Today, Dr. Johnson has four-generations of family members that also enjoy skiing. With family and friends cheering him on, Dr. Johnson skied a short distance to celebrate his 100th year.

"As far as we can tell, Dr. Johnson is the longest standing life-time season pass holder at Snowbasin," said Jodi Holmgren, Snowbasin spokesperson. "It was a pleasure

talking to Dr. Johnson today. His jovial demeanor and active lifestyle through a commitment to the sport of skiing, is certainly a testament to longevity," said Holmgren.






